

Decision of the Authority in the Matter of Adjustment in Insurance Component of Capacity Charge Part of Tariff for Attock Gen Limited (AGL)

- Pursuant to the decision of the Authority dated 24th May 2010 in the matter of Motion for Leave for Review filed by Attock Gen Limited (AGL) against the decision of the Authority at Commercial Operation Date (COD), the insurance component of tariff is subject to adjustment as per actual on yearly basis. AGL vide its letter dated 24th September 2021 requested to approve insurance component of Rs. 0.0787/kW/h on the basis of insurance cost of Rs. 107,488,657 for the period of 1st April 2021 to 31st March 2022. AGL in supports of its request provided copies of insurance policies, premium calculations, payment evidences and payment acknowledgments of insurer.
- 2. Accordingly, on the basis of documents provided by AGL, Schedule VIII of PPA and insurance premium of Rs. 107,488,657, the insurance component of capacity charge part of tariff of AGL has been revised. The revised insurance component of capacity charge part of tariff indicated hereunder shall be immediately applicable:
