
ANNUAL ADJUSTMENT OF INSURANCE COMPONENT OF NATIONAL POWER PARKS MANAGEMENT COMPANY (PRIVATE) LIMITED FOR ITS POWER PROJECT AT BALLOKI FOR THE 1st AND 2nd AGREEMENT YEARS

- 1. Pursuant to the Authority's decision dated May 20, 2020 notified vide S.R.O. No. 485(1)/2021 in the matter of Review Motion against the COD decision, the insurance component of tariff is subject to annual adjustment as per actual cost. NPPMCL-Balloki vide letters dated July 07, 2020 and July 15, 2020 requested to revise the insurance component on RLNG and HSD fuels as Rs. 0.0855/kW/h and Rs. 0.0942/kW/h respectively for the first agreement year and Rs. 0.1401/kW/h and Rs. 0.1544/kW/h respectively for the second agreement year. NPPMCL-Balloki provided copies of insurance policies, premium invoices, copies of cheque, copies of bank statement and payment acknowledgements of insurer.
- 2. NPPMCL-Balloki requested insurance premium of Rs. 901,426,542 for the first agreement year, however, as per the payment evidences the total insurance premium works out Rs.894,719,742. The details of insurance premium paid are provided hereunder:

- 3. As per the approved mechanism, NPPMCL-Balloki is allowed to adjust its insurance component annually on the basis of Actual Premium or 1% of the EPC cost at exchange rate prevailing on the 1st day of the insurance coverage period, whichever is lower. Accordingly 1% of the EPC cost of US\$ 5.344 million for the 1st and 2nd agreement years works out Rs. 685,102,082 and Rs.859,316,808 respectively at prevailing exchange rate of Rs. 128.20/US\$ and Rs. 160.80/US\$.
- 4. The requested insurance premiums works out 1.31% and 1.72% of the approved EPC cost for the 1st and 2nd agreement year respectively and are higher than the approved limit of insurance cost. Therefore, as per the approved mechanism insurance premium as per capped limit is considered for adjusted insurance components of both years.
- 5. Accordingly, on the basis of information/documents provided by NPPMCL-Balloki and in accordance with the Schedule VIII of Power Purchase Agreement, the insurance component of capacity charge part of tariff has been revised. The revised insurance component of capacity charge part of tariff indicated hereunder shall be immediately applicable:
