

**DECISION OF THE AUTHORITY IN THE MATTER OF ADJUSTMENT IN INSURANCE COMPONENT OF
TARIFF OF THREE GORGES FIRST WIND FARM PAKISTAN (PVT) LIMITED**

Pursuant to the decision of the Authority dated January 22, 2016 in the matter of tariff adjustment of Three Gorges First Wind Farm Pakistan (Pvt.) Limited (TGFWFPL) at Commercial Operation Date (COD) notified vide S.R.O No 361(I)/2016 dated April 20, 2016 and in the matter of Motion for Leave for Review dated October 28, 2016 against the Decision of the Authority at COD, the revised insurance amount and corresponding insurance component of tariff of TGFWFPL based for the period from November 26, 2019 to November 25, 2020 is indicated as under:

- CPPA-G to ensure that all the payments are consistent with tariff determination.

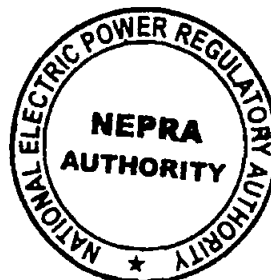
