



**DECISION OF THE AUTHORITY IN THE MATTER OF ADJUSTMENT IN INSURANCE  
COMPONENT OF TARIFF OF FOUNDATION WIND ENERGY-II (Private) LIMITED**

Pursuant to the decision of the Authority dated June 9, 2016 in the matter of tariff adjustment of Foundation Wind Energy-II (Private) Limited (FWEL-II) at commercial operation date (COD), the insurance cost and corresponding component of tariff of FWEL-II for the period from July 01, 2021 to June 30, 2022 has been revised as under:

3. CPPA-G to ensure that all the payments are consistent with tariff determination.

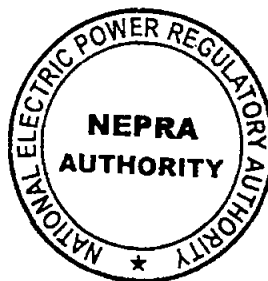
