



**DECISION OF THE AUTHORITY IN THE MATTER OF ADJUSTMENT IN INSURANCE
COMPONENT OF TARIFF OF SACHAL ENERGY DEVELOPMENT (PVT.) LIMITED**

Pursuant to the decision of the Authority dated June 01, 2018 in the matter of tariff adjustment of Sachal Energy Development (Pvt.) Limited (SEDPL) at Commercial Operations Date (COD), the insurance cost and corresponding component of tariff of SEDPL, for the period from April 11, 2021 to April 10, 2022 is tabulated as hereunder,

2. The claims of insurance with respect to motor insurance, health and life insurance not been considered as the same were not covered in the scope of insurance as given in the EPA.
3. The revised tariff component is to be notified in the official gazette, in accordance with the provision of Section 31(7) of the Regulation of Generation, Transmission and Distribution of Electric Power Act, 1997.
4. CPPA-G to ensure that all the payments are consistent with tariff determination.




