





3. CPPA(G) to ensure that all payments are consistent with the tariff determination(s).

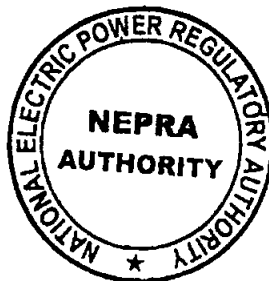
