Pursuant to the decision of the Authority dated March 13, 2015 in the matter of application of Engro Powergen Thar (Private) Limited (hereafter "EPTPL") for unconditional acceptance of Upfront Thar Coal tariff for 2x330 MW coal power plant, the relevant tariff components in respect of Apr-Jun 2021 quarter have been revised on account of US CPI, CPI (General), KIBOR/LIBOR, Government of Sindh water price, exchange rate and coal price(s) variation. - 5. CPPA (G) to ensure that all payments are consistent with the tariff determination(s).

The indexation of Local O&M components is being made on provisional basis, subject to revision upon decision of new reference index value by the Authority.
