- Pursuant to the decision of the Authority dated November 02, 2015 regarding One-1. Time Adjustment of Upfront Tariff of RYK Mills Limited ("RYKML") on achieving commercial operations, notified vide S.R.O No. 22(1)/2016 dated January 07, 2016 and a corrigendum issued by the Authority dated October 31, 2016 regarding the decision dated November 02. 2015, the tariff of RYKML has been revised for the quarter April-June, 2021, on account of US CPI, CPI (General), exchange rate and KIBOR variation in accordance with the requisite indexation/adjustment mechanisms stipulated in the aforementioned decision(s) of the Authority. However, Pakistan Bureau of Statistics has discontinued the publication of CPI for base year 2007-08 w.e.f. July 2020 and replaced it with National CPI for new base year 2015-16.

The Authority vide its decision dated March 10, 2021 replaced CPI Base Year 2007-08 with N-CPI Base Year 2015-16, however, that decision shall be implemented upon Notification in the Official Gazette.

As per relevant provision of the EPA, the latest available CPI of June 2020 for base year 2007-08 has been used for the instant indexation/adjustment. The indexation of Local O&M components is being made on provisional basis, subject to revision upon notification of the Authority's decision of revised index. η
