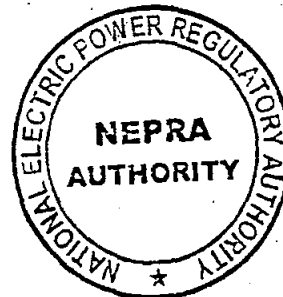
3. CPPA-G to ensure that all the payments are consistent with tariff determination.



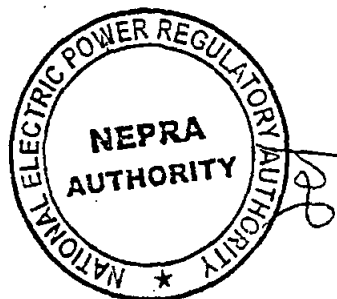
