## DECISION OF THE AUTHORITY IN THE MATTER OF QUARTELY INDEXTION ADJUSTMNET OF TARIFF FOR NORTHERN POWER GENERATION LIMITED (NPGCL) FOR ITS NANDIPUR POWER PLANT FOR JULY TO SEPTEMBER 2023 QUARTER.

Pursuant to the Authority's decision dated January 27, 2016 notified vide S.R.O No. 634(I)/2017 dated July 10, 2017 and Authority's decision dated April 11, 2022, notified vide S.R.O. No 743(I)/202 on May 27, 2022 for NPGCL's combined cycle power plant at Nandipur Gujranwala, indexation/adjustment for July to September 2023 quarter has been made in the tariff components on account of US CPI. CPI Local and Exchange Rate variation in accordance with the requisite indexation/adjustment mechanism stipulated in the decision of the Authority. The revised components are indicated hereunder shall be immediately applicable:
