S.R.O. 1606 (I)/2023.- In pursuance of Proviso-ii of Sub-Section 7 of Section 31 of the Regulation of Generation, Transmission and Distribution of Electric Power Act, 1997 (XL of 1997), NEPRA hereby notifies the Decision of the Authority in the matter of Quarterly Indexation/Adjustment of Local O&M Components of Tariff for **March 2022 to July-September 2023** Quarters of Tariff for Lucky Electric Power Company Limited (LEPCL) on account of N-CPI variations in Case No. NEPRA/TRF-369/LEPCL-2015.

2. While effecting the Decision, the concerned entities including Central Power Purchasing Agency Guarantee Limited (CPPAGL) shall keep in view and strictly comply with the orders of the courts notwithstanding this Decision.

DECISION OF THE AUTHORITY IN THE MATTER OF QUARTELY INDEXATION/ADJUSTMENT OF LOCAL O&M COMPONENTS OF TARIFF FOR MARCH 2022 TO JULY-SEPTEMBER 2023 QUARTERS OF TARIFF FOR LUCKY ELECTRIC POWER COMPANY LIMITED (LEPCL).


1. Pursuant to the decision of the Authority dated March 10, 2021 notified vide S.R.O. No. 1041(I)/2023 on August 9, 2023 in the matter of change of Base Year 2007-08 to Base Year 2015-16 for Consumer Price Index (CPI), the local variable and fixed O&M components of tariff of Lucky Electric Power Company Limited (hereinafter "LEPCL") in respect of March 2020 to Jul-Sep 2023 quarters are required to be adjusted on account of N-CPI variations.
2. The Authority through its various decisions approved Local fixed & variable O&M components of tariff w.e.f. 21st March 2022 to July-September 2023 quarters based on last available CPI value i.e. 269.270 of June 2020 (Base Year 2007-08) on provisional basis subject to decision of the Authority for change in CPI index and its notification in the Official Gazette.
3. Subsequent to the notification of the decision regarding change of base year for CPI, LEPCL requested for revision of Local fixed O&M components based on N-CPI values for 21st March 2022 to Jul-Sep 2023 quarters.
4. The Authority in its collective and joint wisdom decided with consensus as under; which will be hereafter called as decision of the Authority in the matter:-

"Local fixed & variable O&M components have been revised on account of N-CPI variation in accordance with the requisite indexation/adjustment mechanism stipulated in the decision of the Authority. The revised tariff indicated at **Annex-I** shall be immediately applicable."
5. The instant decision shall supersede the relevant decisions of the Authority to the extent of Local Variable & Fixed O&M components dated April 26, 2022, September 13, 2022, October 28, 2022, March 17, 2023, May 29, 2023 and August 11, 2023.
6. Indexation allowed to LEPCL is purely on provisional basis till finalization of its COD tariff by the Authority and shall be subject to adjustment/refund, if necessary, in the light of final decision of the Authority.
7. This decision along with **Annex-I** are to be notified in the official Gazette, in accordance with the provisions of Section 31(7) of the Regulation of Generation, Transmission and Distribution of Electric Power Act 1997.
8. CPPA (G) to ensure that all payments are consistent with the tariff determination(s).
