#### OF OUARTERI DECISION THE THE MATTER OF AUTHORITY IN INDEXATION/ADJUSTMENT OF LOCAL VARIABLE & FIXED O&M COMPONENTS OF TARIFF. FOR OCT-DEC 2020 TO JUL-SEP 2023 QUARTERS FOR ATTOCK GENERAL LIMITED.

Pursuant to the decision of the Authority dated May 24, 2010 in the matter of Motion for Leave for Review filed by Attock General Limited (AGL), decision of the Authority dated December 20, 2012 regarding change of index in the case of AGL and decision of the Authority dated March 10, 2021 notified vide SRO No. 1041(I)/2023 on August 9, 2023 in the matter of Change of Base Year 2007-08 to 2015-16 for Consumer Price Index (CPI), the local variable & fixed O&M components of tariff are required to be adjusted on account of variation in N-CPI.

The Authority through its various decisions approved Local Variable & Fixed O&M Components of tariff w.e.f. October-December 2020 to July-September 2023 quarters based on last available CPI value i.e. 269.270 of June 2020 (Base Year 2007-08) on provisional basis subject to decision of the Authority for change in CPI index and its notification in the Official Gazette.

Subsequent to the notification of the decision, AGL vide its letter dated August 24, 2023 requested for revision of Local Variable & Fixed O&M components based on N-CPI values for October -December 2020 to July - September 2023 quarters.

The Authority in its collective and joint wisdom decided with consensus as under; which will be hereafter called as decision of the Authority in the matter:-

"Local Variable & Fixed O&M components have been revised on account of N-CPI variation in accordance with the requisite indexation/adjustment mechanism stipulated in the decision of the Authority dated March 10, 2021. The revised tariff indicated at Annex-I shall be immediately applicable."

The instant decision shall supersede the relevant decisions of the Authority to the extent of Local Variable & Fixed O&M components dated October 27, 2020, April 27, 2021, July 26, 2021, October 20, 2021, January 21, 2022, April 28, 2022, July 26, 2022, October 28, 2022, February 1, 2023, May 12, 2023 and July 25, 2023.

The revised tariff components attached as Annex-I are to be notified in the official Gazette, in accordance with the provision of Section 31(7) of the Regulation of Generation, Transmission and Distribution of Electric Power Act, 1997.
