2. While effecting the Decision, the concerned entities including Central Power Purchasing Agency Guarantee Limited (CPPAGL) shall keep in view and strictly comply with the orders of the courts notwithstanding this Decision.

### DECISION OF THE AUTHORITY IN THE MATTER OF QUARTERLY INDEXATION/ ADJUSTMENT OF LOCAL O&M COMPONENTS OF TARIFF FOR OCT-DEC 2020 TO JUL-SEP 2023 QUARTERS FOR ENGRO POWERGEN QADIRPUR LIMITED.

Pursuant to the Decision of the Authority dated March 10, 2021 notified vide S.R.O. No. 1041(I)/2023 on August 9, 2023 in the matter of change of Base Year 2007-08 to Base Year 2015-16 for Consumer Price Index (CPI), the local fixed and variable O&M components of tariff of Engro Powergen Qadirpur Limited (EPQL), formerly Engro Energy Limited in respect of October-December 2020 to July-September 2023 quarters are required to be indexed on account of National-CPI (N-CPI) variations.

The Authority through its various decisions approved Local fixed & variable O&M components of tariff w.e.f. Oct-Dec 2020 to Jul-Sep 2023 quarters based on last available CPI value i.e. 269.270 of June 2020 (Base Year 2007-08) on provisional basis subject to decision of the Authority for change in CPI index and its notification in the Official Gazette.

Subsequent to the notification of the decision regarding change of base year for CPI, EPQL requested for revision of Local fixed & variable O&M components based on N-CPI values for Oct-Dec 2020 to Jul-Sep 2023 quarters.

The Authority in its collective and joint wisdom decided with consensus as under; which will be hereafter called as decision of the Authority in the matter:-

"Local fixed & variable O&M components have been revised on account of N-CPI variation in accordance with the requisite indexation/adjustment mechanism stipulated in the decision of the Authority. The revised tariff indicated at **Annex-I** shall be immediately applicable."

The instant decision shall supersede the relevant decisions of the Authority to the extent of Local fixed & variable O&M components dated October 27, 2020, January 25, 2021, April 27, 2021, July26, 2021, October 20, 2021, January 21, 2022, April 22, 2022, August 11, 2022, October 21, 2022, February 10, 2023, May 12, 2023 and July 25, 2023.

This decision along with Annex-I are to be notified in the official Gazette in accordance with the provisions of Section 31(7) of the Regulation of Generation, Transmission and Distribution of Electric Power Act 1997.
