S.R.O. 1703 (I)/2023. - In pursuance of Proviso-ii of Sub-Section 7 of Section 31 of the Regulation of Generation, Transmission and Distribution of Electric Power Act, 1997 (XL of 1997), NEPRA hereby notifies the Decision of the Authority in the matter of quarterly indexation/ adjustment of local O&M components of tariff for **February 17, 2023 to July – September 2023** quarters of tariff for ThalNova Power Thar (Pvt.) Limited (TNL) on account of N-CPI variations in Case No. NEPRA/TRF-367/TPTPL-2016.

2. While effecting the Decision, the concerned entities including Central Power Purchasing Agency Guarantee Limited (CPPAGL) shall keep in view and strictly comply with the orders of the courts notwithstanding this Decision.

DECISION OF THE AUTHORITY IN THE MATTER OF QUARTELY INDEXATION/ADJUSTMENT OF LOCAL O&M COMPONENTS OF TARIFF FOR FEB 17, 2023 TO JUL-SEP 2023 QUARTERS OF TARIFF FOR THALNOVA POWER THAR (PVT.) LIMITED (TNL).

1. Pursuant to the decision of the Authority dated October 18, 2016 in the matter of Napproval of upfront Thar coal tariff for 330 MW coal power plant of ThalNova Power Thar (Pvt.) Limited (hereinafter "TNL") and decision of the Authority dated March 10, 2021 notified vide S.R.O. No. 1041(I)/2023 on August 9, 2023 in the matter of change of Base Year 2007-08 to Base Year 2015-16 for Consumer Price Index (CPI) for indexation of local O&M components, the local fixed & variable O&M components of tariff of TNL are required to be indexed on account of N-CPI variations.
2. The Authority through its various decisions approved local variable & fixed O&M components of tariff w.e.f. February 17, 2023 to July-September 2023 quarters based on last available CPI value i.e. 269.270 of June 2020 (Base Year 2007-08) on provisional basis subject to decision of the Authority for change in CPI index and its notification in the Official Gazette.
3. Subsequent to the notification of the decision regarding change of base year for CPI, TNL requested for revision of local variable & fixed O&M components based on N-CPI values for Feb 17, 2023 to Jul-Sep 2023 quarters.
4. The Authority in its collective and joint wisdom decided with consensus as under; which shall be hereafter called as decision of the Authority in the matter:-

"Local variable & fixed O&M components of tariff in respect of Feb 17, 2023 to Jul-Sep 2023 quarters have been revised on account of N-CPI variation in accordance with the requisite indexation mechanism stipulated in the decisions of the Authority. The revised tariff indicated at **Annex-I** shall be immediately applicable."
5. Indexation allowed to TNL is on provisional basis till the finalization of its COD tariff decision by the Authority and shall be subject to adjustment/refund, if necessary, in the light of final decision of the Authority in respect to COD tariff adjustment.
6. The instant decision shall supersede the relevant decisions of the Authority to the extent of local fixed & variable O&M components dated August 11, 2023.
7. This decision along with **Annex-I** are to be notified in the official Gazette, in accordance with the provisions of Section 31(7) of the Regulation of Generation, Transmission and Distribution of Electric Power Act 1997.
8. CPPA (G) to ensure that all payments are consistent with the tariff determination(s).

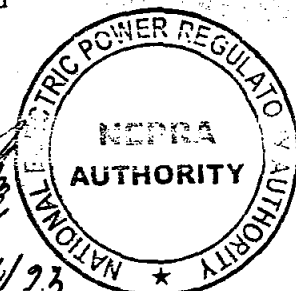

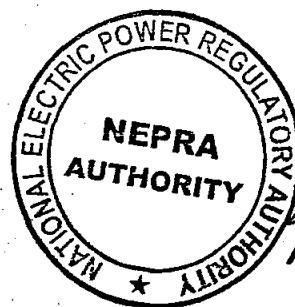
