DECISION OF THE AUTHORITY IN THE MATTER OF ANNUAL INDEXATION/ADJUSTMENT OF TARIFF FOR JAGRAN-I HYDROPOWER PROJECT AJ&K

Pursuant to the Decision of the Authority dated Septemberc 14, 2018 in the matter of the tariff proposal submitted by Central Power Purchasing Agency Guarantee Limited (CPPA-G) for the Import of power from 30.4 MW Jagran-I Hydropower Project located in AJ&K notified vide S.R.O No. 937(I)/2019 dated August 16, 2019, the variable component of the of Jagran-I Hydropower Project is required to be indexed as per the stipulated mechanism.
