COMPONENT OF TARIFF FOR ACT WIND (PRIVATE) LIMITED**

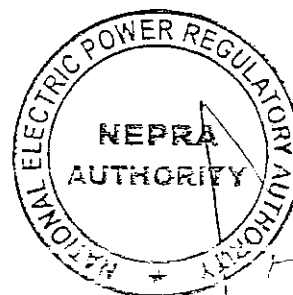

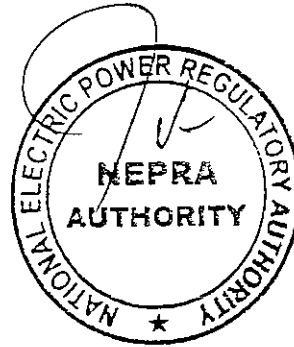
