DECISION OF THE AUTHORITY IN THE MATTER OF OUARTERLY INDEXATION/ADJUSTMENT OF LOCAL FIXED AND VARIABLE O&M COMPONENTS OF TARIFF FOR OCTOBER - DECEMBER 2020 TO APRIL - JUNE 2023 QUARTERS FOR SINDH NOORIABAD POWER COMPANY (PRIVATE) LIMITED (SNPCL) PHASE-II.

Pursuant to the decision of the Authority dated March 10, 2021 notified vide S.R.O. No. 1041(I)/2023 on August 09, 2023 in the matter of change of base year 2007-2008 to base year 2015-16 for Consumer Price Index (CPI) for indexation of fixed and variable O&M (Local) components, the local fixed and variable O&M components of tariff are required to be adjusted on account of variation in N-CPI.

The Authority through its various decisions approved local fixed and variable O&M components of tariff w.e.f. October - December 2020 to April - June 2023 quarters based on last available CPI value i.e. 269.270 of June 2020 (Base Year 2007-08) on provisional basis subject to decision of the Authority for change in CPI index and its notification in the Official Gazette.

Subsequent to the notification of the decision, SNPCL Phase-II requested for revision of local fixed and variable O&M components based on N-CPI values for October - December 2020 to April - June 2023 quarters.

The Authority in its collective and joint wisdom decided with consensus as under; which will be hereafter called as decision of Authority in the matter:-

"Local Fixed and Variable O&M components have been revised on account of N-CPI variation in accordance with the requisite indexation/adjustment mechanism stipulated in the decision of the Authority for October - December 2020 to April - June 2023 quarters. The revised tariff indicated as Annex-I shall be immediately applicable."

The instant decision shall supersede the relevant decisions of the Authority to the extent of local fixed and variable O&M components dated November 5, 2020, March 1, 2021, April 27, 2021, July 26, 2021, June 20, 2022, August 11, 2022, October 21, 2022, April 28, 2023 and May 12, 2023.

Indexation allowed to SNPCL-II is purely on provisional basis and shall be subject to adjustment/refund, if necessary, in the light of COD tariff true-up decision and pending court case in Islamabad High Court.

The revised tariff components attached as Annex-I are to be notified in the Official Gazette, in accordance with the provisions of Section 31(7) of the Regulation of Generation, Transmission and Distribution of Electric Power Act, 1997.

KE to ensure that all payments are consistent with the tariff determination(s).
