DECISION OF THE AUTHORITY IN THE MATTER OF ADJUSTMENT OF INSURANCE COMPONNET OF CAPACITY CHARGE PART OF TARIFF OF HUANENG SHANDONG RUYI (PAKISTAN) ENERGY (PRIVATE) LIMITED FOR 5TH AGREEMENT YEAR (OCTOBER 28, 2021 TO OCTOBER 27, 2022).


- 1. Pursuant to the Decisions of the Authority dated March 31, 2015 in the matter of approval of upfront coal tariff for 2x660 MW coal power plant of Huaneng Shandong Ruyi (Private) Company Limited (HSRPEL) and dated January 17, 2019 in the matter of tariff adjustment at Commercial Operation Date (COD), the insurance component of tariff is subject to annual adjustment as per actual cost.
- 2. HSRPEL vide letter No. HSR-SW-2022-166 dated October 24, 2022 and revised letter No. HSR-SW-2022-182 dated November 14, 2022 requested to approve insurance component of Rs. 0.1152/kw/h for the 5th agreement year. HSRPEL in support of its request provided copies of insurance policies, premium invoices, sales tax invoices, payment instruments, no claim bonus certificates of Adamjee Insurance and EFU General.
- 3. HSRPEL paid total insurance premium of Rs. 1,254,869,563 including sales tax of Rs. 167,519,824 and the same was requested for calculation of revised insurance component. The detail of requested insurance premium is provided hereunder:



- 4. Schedule VIII of the Power Purchase Agreement does not provide for health insurance, therefore, in line with other power plants, health insurance of Rs. 29,880,203 has not been considered.
- 5. HSRPEL has also included Sales tax in the calculation of requested insurance cost component of tariff which is not in line with previous decisions and decisions in other similar cases. Therefore, the sales tax amount of Rs. 167,519,824 has not been considered. However, in case FBR declares sales tax on insurance as non adjustable, the same may be claimed as pass-through item under Section 11.3(c) of Schedule I of the PPA from the power purchaser in line with Authority's decision in a similar case.
- 6. Accordingly, the insurance component has been revised on the basis of insurance cost of Rs. 1,057,469,536/- for the 5th agreement year. The revised insurance component of capacity charge part of tariff indicated hereunder shall be immediately applicable:
