**DECISION OF THE AUTHORITY IN THE MATTER OF ADJUSTMENT IN INSURANCE COMPONENT OF CAPACITY CHARGE PART OF TARIFF FOR ATTOCK GEN LIMITED (AGL).**

1. Pursuant to the decision of the Authority dated May 24, 2010 in the matter of Motion for Leave for Review filed by Attock Gen Limited (AGL) against the decision of the Authority at Commercial Operation Date (COD), the insurance component of tariff is subject to adjustment as per actual on yearly basis. AGL requested to approve insurance component of Rs. 0.1163/kW/h on the basis of insurance cost of Rs. 158,868,991 for the period of April 1, 2022 to March 31, 2023. AGL in supports of its request provided copies of insurance policies, premium calculations, payment evidences and payment acknowledgments of insurer.
2. The detail of insurance premium paid is provided hereunder:







5. CPPA (G) to ensure that all payments are consistent with the tariff determination.

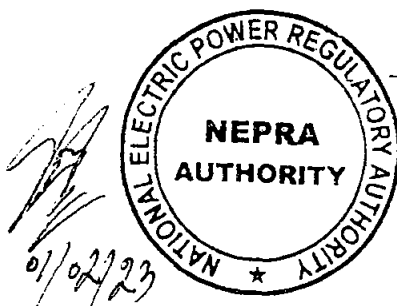

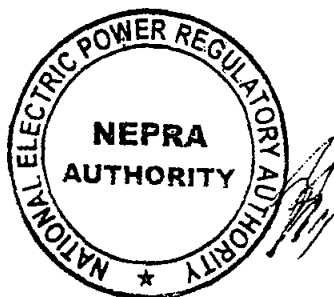
