#### **Decision of the Authority**

In the Matter of Approval of the PPA for Procurement of Up to 4.0 MW (Bagasse Based) Power from M/s Bandhi Sugar Mills Limited (BSML) under NEPRA IPPR-2005

NEPRA granted generation license to BSML dated August 26, 2013 in respect of 12 MW bagasse based generation facility at Bandhi, Nawabshah.

- NEPRA approved the Power Acquisition Request (PAR) filed by HESCO for procurement of 2. power form BSML on November 05, 2021 and directed to negotiate Power Purchase Agreement and submit the same for approval of the Authority.
- In pursuance to regulation 5(1) of IPPR-2005, HESCO vide its letter dated December 12, 2022 submitted the PPA for procurement of up to 04 MW power from BSML, for 05 years from signing of the PPA.
- 4. The Authority considered the matter and decided to approve the PPA for purchase of up to 4 MW power by HESCO from BSML, under regulation 5(1) of IPPR-2005

### **ORDER**

- In pursuance of Regulation 5 of NEPRA Interim Power Procurement (Procedure & Standards) Regulations 2005 read with Section 7 & 31(7) of the Regulation of Generation, Transmission and Distribution of Electric Power Act, 1997, the power purchase agreement between Hyderabad Electric Supply Company (HESCO) and Bandhi Sugar Mills Limited (BSML) for acquisition of power of up to 4 MW on "take and pay" basis is hereby approved subject to the following conditions:
  - i. The tariff of Rs. the fuel cost component (Rs. 6.04/kWh) and fixed cost component (Rs. 1.53/kWh),
  - ii. The contractual disputes, referred in clause (v) of the PPA, shall be resolved under Arbitration Act, 1940 instead of referral to NEPRA.
- The cost of purchase of energy from BSML shall be accounted for in the basket of HESCO, iii. instead of CPPAGL.
- iv. For any subsequent adjustment in the tariff, the parties shall request the Authority for its approval.
