DECISION OF THE AUTHORITY IN THE MATTER OF QUARTERLY INDEXATION/ADJUSTMENT OF TARIFF OF 102 MW GULPUR HYDRO POWER PROJECT OF MIRA POWER LIMITED.

Pursuant to the decisions of the Authority dated August 3rd, October 28th, 2015 and March 09, 2021, in the matter of request filed by Central Power Purchasing Agency for procurement of power from Mira Power Ltd.'s 102 MW Gulpur Hydropower Project the tariff components of MPL have been indexed from October 1st 2022 to December 31st 2022, only to extent of applicable exchange rate variation. The revised tariff indicated in the attached **Annex-I** shall be immediately applicable.

The indexation allowed shall be subject to adjustment, if necessary, in the light of the final decision of the Authority w.r.t MPL's COD tariff adjustment.


