### **MATTER** DECISION **AUTHORITY** THE OF THE IN OF **OUARTERLY** INDEXATION/ ADJUSTMENT OF TARIFF FOR SAPPHIRE COMPANY LIMITED FOR JANUARY TO MARCH 2023 QUARTER.
