DECISION OF THE AUTHORITY IN THE MATTER OF QUARTERLY INDEXATION/ADJUSTMENT OF TARIFF FOR SAPPHIRE ELECTRIC COMPANY LIMITED FOR APRIL TO JUNE 2023 QUARTER.

The indexation of Local O&M components is being made on provisional basis, subject to revision upon decision of new reference index value by the Authority.
