S.R.O. 274 (I)/2024. - In pursuance of Proviso-ii of Sub-Section 7 of Section 31 of the Regulation of Generation, Transmission and Distribution of Electric Power Act, 1997 (XL of 1997), NEPRA hereby notifies the Decision of the Authority dated 29th January, 2024 in the matter of Quarterly Indexation/Adjustment of Fixed and Variable (Local & Foreign) O&M components of Tariff for **6th January – March 2018 to July – September 2023** Quarters for Northern Power Generation Company Limited for its Nandipur Power Plant in Case No. NEPRA/TRF-271/NPGCL-2014.

2. While effecting the Decision, the concerned entities including Central Power Purchasing Agency Guarantee Limited (CPPAGL) shall keep in view and strictly comply with the orders of the courts notwithstanding this Decision.

DECISION OF THE AUTHORITY IN THE MATTER OF QUARTELY INDEXATION/ADJUSTMENT OF FIXED AND VARIABLE (LOCAL & FOREIGN) O&M COMPONENTS OF TARIFF FOR 6TH JANUARY-MARCH 2018 TO JULY-SEPTEMBER 2023 QUARTERS FOR NORTHERN POWER GENERATION COMPANY LIMITED (NPGCL) FOR ITS NANDIPUR POWER PLANT.

Pursuant to the Authority's decision dated January 27, 2016 notified vide S.R.O No. 634(I)/2017 dated July 10, 2017, Authority's decision dated April 11, 2022, notified vide S.R.O. No 743(I)/202 on May 27, 2022 for NPGCL's combined cycle power plant at Nandipur Gujranwala and the decision of the Authority dated March 10, 2021 notified vide S.R.O. No. 1041(I)/2023 on August 09, 2023 in the matter of change of base year 2007-2008 to base year 2015-16 for Consumer Price Index (CPI) for indexation of fixed and variable O&M (Local) components, the relevant tariff components are required to be adjusted on account of US CPI, CPI/N-CPI and Exchange Rate variation.

The Authority in its collective and joint wisdom considering all aspects decided with consensus as under; which will be hereafter called as decision of Authority in the matter:-

"Local and Foreign Fixed and Variable O&M components have been revised on account of CPI/N-CPI, US CPI and Exchange Rate variation in accordance with the requisite indexation/adjustment mechanism stipulated in the decision(s) of the Authority for 6th January-March 2018 to July-September 2023 quarters. The revised tariff indicated as Annex-I shall be immediately applicable."


The instant decision shall supersede the relevant decisions of the Authority dated February 23, 2018, June 20, 2018, August 17, 2018, December 17, 2018, January 31, 2019, April 30, 2019, August 22, 2019, November 26, 2019, February 11, 2020, April 28, 2020, July 27, 2020, October 27, 2020, February 3, 2021, May 17, 2021, August 2, 2021, November 3, 2021, January 21, 2022, April 26, 2022, August 25, 2022, October 28, 2022, February 22, 2023, May 5, 2023 and August 9, 2023 to the extent of O&M components.

Indexation allowed to NPGCL-Nandipur is purely on provisional basis till finalization of its COD tariff by the Authority and shall be subject to adjustment, if necessary, in the light of final decision of the Authority.



CPPA (G) to ensure that all payments are consistent with the tariff determination(s).


