**DECISION OF THE AUTHORITY IN THE MATTER OF ADJUSTMENT IN INSURANCE
COMPONENT OF TARIFF FOR HARAPPA SOLAR PRIVATE LIMITED**

Pursuant to the decision of the Authority dated November 20, 2018 in the matter of Tariff adjustment of Harappa Solar Private Limited (HSPL) at Commercial Operation Date (COD) and subsequent decision dated April 09, 2021, HSPL submitted the request for the revised insurance cost and corresponding insurance component of tariff of HSPL for the period from October 14, 2023 to October 13, 2024.

2. The Authority in its collective and joint wisdom considering all aspects decided with consensus as under; which will be hereafter called as decision of the Authority in the matter:

"Based on the information provided by the HSPL, adjustment in insurance component for the period October 14, 2023 to October 13, 2024 has been made in accordance with the requisite indexation/adjustment mechanism stipulated in the decision(s) of the Authority. The revised component is indicated hereunder shall be immediately applicable."

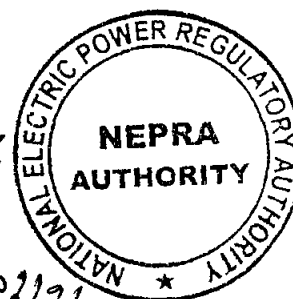
