DECISION OF THE AUTHORITY IN THE MATTER OF ADJUSTMENT IN INSURANCE COMPONENT OF TARIFF FOR APPOLO SOLAR DEVELOPMENT LTD (ASDPL)

Pursuant to the decision of the Authority dated November 16, 2017 in the matter of tariff adjustment of Appolo Solar Development Pakistan at Commercial Operations Date (COD) notified vide SRO 119(U/2018 dated January 25, 2018, ASDPL vide letter dated Aug 28, 2023, submitted request for adjustment of insurance component tariff for the period from May 31, 2021 to May 30, 2022. ASDPL has claimed total insurance premium of Rs. 85,283,901 (excluding sales tax), the revised insurance premium along with insurance component is given in table below;
