DECISION OF THE AUTHORITY IN THE MATTER OF ANNUAL ADJUSTMENT OF SINOSURE COMPONENT OF CAPACITY CHARGE PART OF TARIFF FOR PORT QASIM ELECTRIC POWER COMPANY (PRIVATE) LIMITED

- 1. Pursuant to the Decisions of the Authority dated February 13, 2015 in the matter of approval of upfront coal tariff for 2x660 MW coal power plant of Port Qasim Electric Power Company (PQEPCL) and dated September 27, 2019 in the matter of tariff adjustment at Commercial Operation Date (COD) of PQEPCL, the sinosure component of capacity charge part of tariff is subject to annual adjustment on the basis of annual outstanding principal, interest payable and exchange rate. PQEPCL submitted its request for adjustment of Sinosure fee component. PQEPCL requested Sinsosure fee component of Rs. 0.1716/kW/h for the 6th agreement year on the basis of sinosure premium of US\$ 6,527,808 (Rs. 1,868,911,548 @ Rs. 286.3/US\$).
- 2. The Authority in its collective and joint wisdom considering all aspects decided with consensus as under which shall be hereafter called as decision of the Authority in the matter:

"Based on the documentary evidence and information submitted by PQEPCL, the sinosure component of capacity charge part of PQEPCL's tariff is adjusted for variation in coal price for the 6th agreement year."

3. PQEPCL calculated the sinosure premium on the basis of outstanding principle as per the loan agreement with its Lender instead of the debt schedule approved by NEPRA. The requested sinosure premium is not in line with the mechanism approved by the Authority and previous decisions in the matter. As per the approved mechanism, sinosure premium for the period November 24, 2023 to November 23, 2024 is calculated as under:
