

DECISION OF THE AUTHORITY IN THE MATTER OF ADJUSTMENT IN INSURANCE
COMPONENT OF TARIFF OF METRO POWER COMPANY LIMITED

Pursuant to the decision of the Authority dated February 22, 2019 in the matter of tariff adjustment of Metro Power Company Limited (MPCL) at Commercial Operation Date (COD) notified vide S.R.O No 571(I)/2019 dated May 20, 2019 and decision issued on December 05, 2019 in the matter of motion for leave for review against the COD tariff decision of the Authority, MPCL requested for the insurance cost and corresponding component of tariff for the period from September 16, 2023 to September 15, 2024 is given as under:

2. The Authority in its collective and joint wisdom considering all aspects decided with consensus as under; which will be hereafter called as decision of the Authority in the matter:

"Based on the information provided by the MPCL, adjustment in insurance component for the period September 16, 2023 to September 15, 2024 has been made in accordance with the requisite indexation/adjustment mechanism stipulated in the decision(s) of the Authority. The revised component is indicated hereunder shall be immediately applicable."

*Revised Insurance premium works out to be 0.58 % of the approved EPC cost.



3. CPPA-G to ensure that all the payments are consistent with tariff determination.





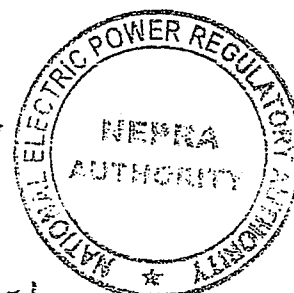
