## DECISION OF THE AUTHORITY IN THE MATTER OF QUARTERLY INDEXATION/ADJUSTMENT OF TARIFF FOR CREST ENERGY PAKISTAN LIMITED FOR THE QUARTER APRIL-JUNE 2024
