S.R.O. 1010 (I)/2024.- In pursuance of Proviso-iv of Sub-Section 7 of Section 31 of the Regulation of Generation, Transmission and Distribution of Electric Power Act, 1997 (XL of 1997), NEPRA hereby notifies the Decision of the Authority dated June 27, 2024 along with Schedule of Fuel Cost Part of Energy Charge, applicable w.e.f. **May 01, 2024, May 08, 2024, May 15, 2024, and May 22, 2024** at **Annex-I** regarding the adjustment in fuel portion of energy charge part of tariff on account of fuel price variation for RLNG price(s) on provisional basis in respect of Saif Power Limited in Case No. NEPRA/TRF-80/SPL-2007.

2. While effecting the Decision, the concerned entities including Central Power Purchasing Agency Guarantee Limited (CPPAGL) shall keep in view and strictly comply with the orders of the courts notwithstanding this Decision.

**DECISION OF THE AUTHORITY IN THE MATTER OF FUEL PRICE ADJUSTMENT
BASED ON RLNG FOR THE MONTH OF MAY 2024 FOR SAIF POWER LIMITED.**

1. Pursuant to the decisions of the Authority dated June 20, 2011 in the matter of tariff adjustments at COD stage and dated May 3, 2016 in the matter of Modification in the existing mechanism of fuel cost component, the fuel portion of energy charge part of the tariff of Saif Power Limited (hereinafter "SPL") is required to be adjusted for variation in fuel price(s).
2. The Authority in its collective and joint wisdom considering all aspects decided with consensus as under; which shall be hereafter called as decision of the Authority in the matter:-


"Based on the documentary and information submitted by SPL and as per the Oil & Gas Regulatory Authority's (OGRA's) notification of provisional weighted average RLNG price(s) dated May 24, 2024 for the month of May 2024, the fuel cost components have been adjusted for variation in RLNG price(s) for the month of May 2024. The revision has been made on provisional basis and final fuel cost components shall be made after notification(s) of final RLNG price(s) determined by OGRA and submission of fuel invoice(s) by SPL."


3. The revised fuel cost components on RLNG for the period of May 2024 are indicated hereunder and shall be immediately applicable on unit delivered the respective periods:





5. CPPA(G) to ensure that all payments are consistent with tariff determination(s).



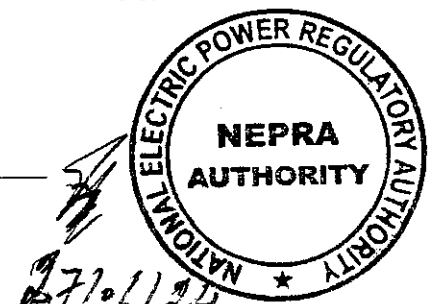

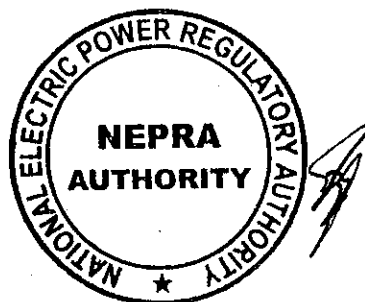
