COMPONENT OF TARIFF OF FOUNDATION WIND ENERGY-I LIMITED**

Pursuant to the decision of the Authority dated October 27, 2016 in the matter of tariff adjustment of Foundation Wind Energy-I Limited (FWEL-I) at commercial operation date (COD) and corrigendum decision dated December 2, 2016, FWEL-I has requested for the insurance cost and corresponding component of tariff for the period from January 01, 2024 to December 31, 2024.

2. The Authority in its collective and joint wisdom considering all aspects decided with consensus as under; which will be hereafter called as decision of the Authority in the matter:



\*Revised Insurance premium works out to be 0.31% of the approved EPC cost.




4. CPPA-G to ensure that all the payments are consistent with tariff determination.


