OF TARIFF OF THREE GORGES FIRST WIND FARM PAKISTAN (PVT) LIMITED**

Pursuant to the decision of the Authority dated January 22, 2016 in the matter of tariff adjustment of Three Gorges First Wind Farm Pakistan (Pvt.) Limited (TGFWFPL) at Commercial Operation Date (COD) notified vide S.R.O No 361(1)/2016 dated April 20, 2016 and in the matter of Motion for Leave for Review dated October 28, 2016 against the Decision of the Authority at COD, the revised insurance amount and corresponding insurance component of tariff of TGFWFPL for the period from November 26, 2023 to November 25, 2024 is indicated as under




Revised Insurance premium works out to be 0.38% of the approved EPC cost.


4. CPPA-G to ensure that all the payments are consistent with tariff determination.

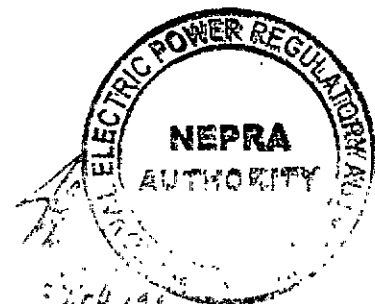
