**S.R.O. 1114 (I)/2024.** - In pursuance of Proviso-iv of Sub-Section 7 of Section 31 of the Regulation of Generation, Transmission and Distribution of Electric Power Act, 1997 (XL of 1997), NEPRA hereby notifies the decision of the Authority dated 25<sup>th</sup> July, 2024 along with **Annex-I** regarding the fuel price adjustment on account of Coal price variation for the month of **June 2024** in respect of China Power Hub Generation Company (Private) Limited in Case No. NEPRA/TRF-342/CPHGCL-2016.

2. While effecting the Decision, the concerned entities including Central Power Purchasing Agency Guarantee Limited (CPPAGL) shall keep in view and strictly comply with the orders of the courts notwithstanding this Decision.

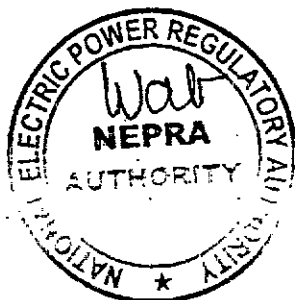
**DECISION OF THE AUTHORITY IN THE MATTER OF FUEL PRICE  
ADJUSTMENT FOR THE MONTH OF JUNE 2024 FOR CHINA POWER  
HUB GENERATION COMPANY PRIVATE LIMITED.**

1. Pursuant to the decision of the Authority dated February 12, 2016 in the matter of Approval of Upfront Coal Tariff for 2x660 MW coal power plant of China Power Hub Generation Private Limited (hereafter "CPHGCL") and decision dated September 23, 2016 regarding Suo Moto Review Proceedings in the matter of Fuel Price Adjustment Mechanism determined in Upfront Coal Tariff, the fuel portion of the energy charge part of CPHGCL's tariff needs to be adjusted for variation in coal price. CPHGCL requested weighted average coal price of Rs. 34,560.29/Ton for coal consumed during the month of June 2024. CPHGCL requested fuel cost component of Rs. 13.7501/kWh for the month of June 2024.
2. CPHGCL consumed coal in June 2024 from Shipment No. 85 part of which was also consumed in November 2023 and May 2024. CPHGCL also consumed coal in June 2024 from Awan Trading - Spot Coal - Invoice # 23240215 part of which was consumed in November 2023. The prices of Shipment No. 85 and Awan Trading - Spot Coal - Invoice # 23240215 were assessed as Rs. 42,440/- and Rs. 35,611/-, respectively, while, determining fuel cost component for the month of November 2023 in accordance with the prescribed mechanism.
3. Similarly, CPHGCL also consumed coal in June 2024 from Awan Trading - Spot Coal - Invoice # 23240217 part of which was consumed in May 2024 and price of this spot coal was assessed as Rs. 30,194/-, while, determining fuel cost component of May 2024 in accordance with the prescribed mechanism.
4. The Authority in its collective and joint wisdom considering all aspects decided with consensus as under which shall be hereafter called as decision of the Authority in the matter:

"Based on the documentary evidence and information submitted by CPHGCL, the fuel cost component of energy charge part of CPHGCL's tariff is adjusted for variation in coal price for the month of June 2024."

5. The revised FCC of energy charge part of CPHGCL's tariff indicated hereunder shall be immediately applicable to the units delivered during the month:

6. The revised fuel cost component attached as **Annex-I** is to be notified in the official gazette, in accordance with the provisions of Section 31(7) of the Regulation of Generation, Transmission and Distribution of Electric Power Act 1997.
7. CPPA (G) to ensure that all payments are consistent with the tariff determination(s).

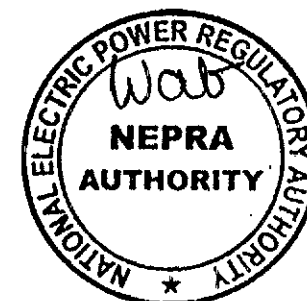
