DECISION OF THE AUTHORITY IN THE MATTER OF ADJUSTMENT IN THE INSURANCE COMPONENT FOR THE 147 MW PATRIND HYDROPOWER PROJECT OF STAR HYDROPOWER LIMITED

- 1. Pursuant to the Authority's Determination in case No.NEPRA/R/SA(Tariff)TRF-172/SHPL-2011/19480-19482 dated July 29, 2020, notified vide S.R.O. 962/(I)/2021 dated July 29, 2021, in the matter of adjustment at commercial operation date and the Decision of the Authority dated May 02, 2024, in the matter of motion for leave for review against the Authority's Determination dated July 29, 2020 the insurance component is required to be adjusted annually as per actual incurred prudent costs, subject to a maximum of 1.35% of the EPC cost, on annual basis upon production of authentic documentary evidence.
- Central Power Purchasing Agency (Guarantee) Limited (CPPA-G) forwarded the request of SHPL for the indexation of insurance components on an annual basis for the period starting from November 08, 2023, to November 07, 2024.
- 3. It was noted that SHPL has claimed the Marine Hull insurance as part of operational insurance, which does not falls under the scope of the scheduled 8 part II of the operational period insurance, therefore the same has been excluded.
- 4. The revised tariff components attached as Annex-I are to be notified in the official gazette, in accordance with the provision of Section 31(7) of the Regulation of Generation, Transmission and Distribution of Electric Power Act 1997.
- 5. CPPA-G to ensure that all payments are consistent with tariff determination(s).
