## DECISION OF THE AUTHORITY IN THE MATTER OF QUARTERLY INDEXATION/ ADJUSTMENT OF TARIFF FOR GHARO SOLAR LIMITED FOR THE QUARTER JUL-SEP 2024

Pursuant to the decision of the Authority dated April 9, 2021 in the matter of tariff adjustment of Gharo Solar Limited (GSL) at Commercial Operation Date (COD) notified vide S.R.O. 867(I)/2021 dated July 7, 2021. The relevant tariff components of tariff if GSL are required to be adjusted quarterly.

- 2. GSL vide letter dated Jul 05, 2024 requested the Authority for quarterly indexation of relevant tariff components for the quarter Jul-Sep 2024. 
