# DECISION OF THE AUTHORITY FOR INDEXATIONS/ADJUSTMENT IN FUEL COST COMPONENT OF HAMZA SUGAR MILLS LIMITED FROM OCT 01, 2018 TO SEP 30, 2024

Pursuant to the Authority's decision(s) dated May 12, 2017, July 16, 2019, and February 07, 2024 the Fuel Cost Component ("FCC") of Hamza Sugar Mills Ltd (HSML) is required to be adjusted.

2. Based on which HSML vide letter dated June 12, 2024 has submitted its request for adjustment in FCC from Oct 01, 2018 to Sep 30, 2024.
