# DECISION OF THE AUTHORITY FOR INDEXATIONS/ADJUSTMENT IN FUEL COST COMPONENT OF JDW SUGAR MILLS LIMITED (UNIT-III) FROM OCT 01, 2018 TO SEP 30, 2024

Pursuant to the Authority's decision(s) dated September 15, 2015, July 16, 2019, and February 07, 2024 the Fuel Cost Component ("FCC") of JDW Sugar Mills Limited (JDWSML-III) is required to be adjusted.

2. Based on which JDWSML-III vide letter dated June 11, 2024 has submitted its request for adjustment in FCC from Oct 01, 2018 to Sep 30, 2024. Accordingly, the Authority in its collective and joint wisdom considering all the aspects, decided with consensus as under; which will be hereafter called as decision of the Authority in the matter:

- 4. CPPAGL to ensure that all the payments are consistent with tariff determination.


