S.R.O. 1555 (I)/2024.- In pursuance of Sub-Section 7 of Section 31 of the Regulation of Generation, Transmission and Distribution of Electric Power Act, 1997 (XL of 1997), NEPRA hereby notifies the decision of the Authority dated July 31, 2024 along with schedule of Insurance Component of Capacity Charge regarding adjustment in insurance component of capacity charge part of Saif Power Limited's tariff on account of Actual Insurance Premium for the period April 30, 2024 to April 29, 2025 in Case No. NEPRA/TRF-99/SPL-2008.

2. While effecting the Decision, the concerned entities including Central Power Purchasing Agency Guarantee Limited (CPPAGL) shall keep in view and strictly comply with the orders of the courts notwithstanding this Decision.

DECISION OF THE AUTHORITY IN THE MATTER OF ADJUSTMENT IN INSURANCE COMPONENT OF CAPACITY CHARGE PART OF TARIFF FOR THE PERIOD OF APRIL 30, 2024 TO APRIL 29, 2025 FOR SAIF POWER LIMITED.

1. Pursuant to the decision of the Authority dated June 20, 2011 in the matter of adjustment at Commercial Operation Date (COD) in the case of Saif Power Limited (SPL), the insurance component of tariff is subject to adjustment as per actual annually. SPL requested to approve insurance component of Rs. 0.1860/kW/Hour for the period April 30, 2024 to April 29, 2025. SPL also submitted copies of insurance policies, premium calculations and payment evidences. The details of requested insurance cost net of sales tax on services is as under:

2. The Authority in its collective and joint wisdom considering all aspects decided with consensus as under; which will be hereafter called as decision of the Authority in the matter:-

"Based on the information and documentary evidence(s) provided by SPL and in accordance with Schedule VIII of the Power Purchase Agreement, the insurance component of capacity charge part of tariff of Rs. 0.1860/kW/h has been revised pertaining to coverage period of April 30, 2024 to April 29, 2025 on the basis of net insurance cost of Rs. 341,772,250."

- 3. The above decision of the Authority along with revised tariff schedule attached as Annex-I are to be notified in the Official Gazette in accordance with the provisions of Section 31(7) of the Regulation of Generation, Transmission and Distribution of Electric Power Act 1997.
- 4. CPPA(G) to ensure that all payments are consistent with tariff determination(s).
