**DECISION OF THE AUTHORITY IN THE MATTER OF REIMBURSEMENT  
REQUEST MADE BY NORTHERN POWER GENERATION COMPANY LIMITED  
FOR ITS OLD BLOCKS ON ACCOUNT OF ADVANCE INCOME TAX FOR THE  
TAX YEAR 2023 PAID TO THE FEDERAL BOARD OF REVENUE (FBR).**

1. Northern Power Generation Company Limited (NPGCL) requested for approval of reimbursement of advance income tax amount of Rs. 88,030,936/- for the tax year 2023 paid to the Federal Board of Revenue (FBR) under Sections 147 and 137 of the Income Tax Ordinance. NPGCL in support of its claim submitted the CPRs No. IT-20220628-0101-1647908, IT-20221230-0101-2422084, IT-20221230-0101-2427043, IT-20230331-0101-2568058, IT-20230626-0101-2468343 and IT-20240115-0101-1321925 and verified invoices of EPP and CPP from the power purchaser i.e. Central Power Purchasing Agency Guarantee Limited (CPPA-G). NPGCL further submitted that out of Rs. 519,708,673/- tax paid, an amount of Rs. 88,030,936/- pertains to NPGCL Old Blocks.
2. As per the Section 11.3(IV) and 24(III) of the decisions of the Authority dated October 19, 2016 and December 30, 2020, *in case NPGCL is obligated to pay any tax, the exact amount paid shall be reimbursed.*
3. Accordingly, the Authority in its collective and joint wisdom considering all aspects decided with consensus as under; which will be hereafter called as decision of Authority in the matter:-


“Based on information and documentary evidence(s) provided by NPGCL, an amount of Rs. 88,030,936/- allowed to claim from Central Power Purchasing Agency Guarantee Limited (CPPA-G) on account of tax amount paid to FBR.”
4. The above decision of the Authority is to be notified in the Official Gazette, in accordance with the provision of Section 31(7) of the Regulation of Generation, Transmission and Distribution of Electric Power Act, 1997.
5. CPPA-G to ensure that all payments are consistent with the tariff determination(s).

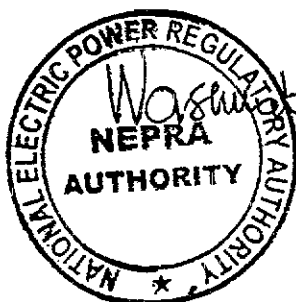
