


**REVISED DECISION OF THE AUTHORITY IN THE MATTER OF QUARTERLY INDEXATION/ADJUSTMENT ON RLNG & HSD FOR APRIL TO JUNE 2018 TO JULY TO SEPTEMBER 2023 QUARTERS FOR QAID-E-AZAM THERMAL POWER (PRIVATE) LIMITED.**

1. The Authority issued decision vide letter No. NEPRA/R/DG(Trf)/TRF-347/QATPL-2016/34837-41 dated October 19, 2023 with respect to quarterly indexation/adjustment on RLNG & HSD for April-June 2018 to July-September 2023 quarters, wherein, a typo error has been noted in 1<sup>st</sup> row of 7<sup>th</sup> column of Annex-IID which needs to be rectified.
2. The Authority in its collective and joint wisdom decided with consensus as under; which will be hereafter called as decision of the Authority in the matter:-

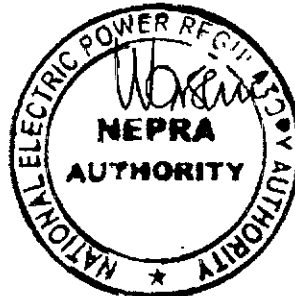
