Decision of the Authority under NEPRA (Review Procedure) Regulations. 2009 for Lucky Renewables (Pvt.) Limited

DECISION OF THE AUTHORITY UNDER NEPRA (REVIEW PROCEDURE) REGULATIONS, 2009 REGARDING DECISION IN THE MATTER OF TARIFF ADJUSTMENT AT COMMERCIAL OPERATIONS DATE OF LUCKY RENEWABLES (PVT.) LIMITED (FORMERLY TRICOM WIND POWER (PVT.) LIMITED) DATED MARCH 22, 2024

- The Authority issued the tariff true-up adjustment of Lucky Renewables (Pvt.) Limited (LRPL) on 1. March 22, 2024. It has been observed that while calculating the component of Return on Equity during Construction (hereinafter "ROEDC"), the exchange rate of Rs. 166.4488/USD was used instead of Rs. 158.30/USD which is an error and needs to be rectified.
- Accordingly, in pursuance of Section 7(2)(g) of the Regulation of Generation, Transmission and 2 Distribution of Electric Power Act, 1997 read with Regulation 3 of NEPRA (Review Procedure) Regulations, 2009, ROEDC component of Rs. 0.2367/kwh appearing at page No. 21 at para 89 be read as Rs.0.2251/kwh and Annex-I is being replaced with the revised Annex-I attached herewith. Accordingly, levelized tariff of Rs 7.2290/kwh and US Cents 4.5667/kwh appearing at page No.23 at para 96 shall be read as Rs. 7.2175/kwh and US Cents 4.5594/kwh respectively.
- Further, the revised ROEDC component approved vide Authority's Decision dated June 03, 2024 3 regarding Quarterly indexation/Adjustment tariff of LRPL for the Quarters from July-September 2021 to July-September 2024 has also been corrected and attached as Annex-II.
- The above decision of the Authority along with Annex-I & II is to be notified in the Official Gazette 4 in accordance with the provisions of Section 31(7) of the Regulation of Generation, Transmission and Distribution of Electric Power Act, 1997. AUTHOR
