Decision of the Authority in the Matter of Adjustment in Insurance Component of Tariff for Zephyr Power Limited.

Pursuant to the decisions of the Authority dated July 08, 2019 in the matter of tariff adjustment of Zephyr Power Limited (ZPL) at Commercial Operation Date (COD) notified vide S.R.O. No 1200(1)/2019 dated September 26, 2019 and in the matter of motion for leave for review dated June 07, 2021, ZPL vide letter dated May 14, 2024, submitted request for adjustment of insurance component tariff for the period from March 28, 2023 to March 27, 2024. ZPL has claimed total insurance premium of Rs. 190,910,359 (excluding sales tax), the revised insurance premium along with insurance component is given in table below;

2. The Authority in its collective and joint wisdom considering all aspects decided with consensus as under; which will be hereafter called as decision of the Authority in the matter:

"Based on the information provided by the ZPL, adjustment in insurance component for the period March 28, 2023 to March 27, 2024 has been made in accordance with the requisite indexation/adjustment mechanism stipulated in the decision(s) of the Authority. The revised component is indicated hereunder shall be immediately applicable."
