DECISION OF THE AUTHORITY IN THE MATTER OF FUEL PRICE ADJUSTMENT W.E.F. SEPTEMBER 16, 2024 FOR FFBL POWER COMPANY LIMITED.

Pursuant to the Decision of the Authority dated May 15, 2017 notified vide S.R.O. No. 1106(I)/2017 on October 26, 2017 in the matter of Motion for Leave for Review, decision dated September 23, 2016 regarding Suo Moto Review Proceedings in the matter of Fuel Price Adjustment Mechanism determined in Upfront Imported Coal tariff and decision of the Authority dated February 9, 2022 notified vide S.R.O. No. 1375(I)/2022 on July 18, 2022 in the matter of adjustment at Commercial Operation Date of FFBL Power Company Limited (hereinafter referred as "FPCL"), the fuel portion of the energy charge part of FPCL's tariff needs to be adjusted for variation in coal price(s). FPCL requested Fuel Cost Components (FCC) of Rs. 18.6832/kWh on the basis of spot coal price of Rs. 38,500/Ton w.e.f. September 16, 2024 and FCC of Rs. 18.3456/kWh on the basis of coal price of Rs.38,342/ton w.e.f. September 30, 2024.

The Authority in its collective and joint wisdom decided with consensus as under which shall be hereafter called as decision of the Authority in the matter:-

"Based on documentary evidences and information submitted by FPCL, the fuel cost component of energy charge part of FPCL's tariff w.e.f. September 16, 2024 is adjusted for variation in coal price."

The revised fuel cost component of energy charge part of FPCL's tariff indicated hereunder shall be immediately applicable to the unit delivered basis w.e.f. September 16, 2024.

FPCL procured coal from two coal suppliers, therefore, FCC has been worked out based on coal consumption and weighted average coal price. Further, FPCL, on November 22, 2024 clarified that Lucky Commodities was able to supply only 10,960 tons of coal against the required coal quantity of 20,000. Consequently, FPCL procured remaining coal from next shortlisted coal supplier i.e. Awan Trading.

The revised fuel cost component along with revised spot coal price(s) attached as Annex-I & II are to be notified in the official Gazette, in accordance with the provisions of Section 31(7) of the Regulation of Generation, Transmission and Distribution of Electric Power Act 1997.

KE to ensure that all payments are consistent with the tariff determination(s).


