DECISION OF THE AUTHORITY IN THE MATTER OF ADJUSTMENT IN INSURANCE COMPONENT OF CAPACITY CHARGE PART OF TARIFF FROM APRIL 23, 2023 TO APRIL 22, 2024 FOR ENGRO POWERGEN QADIRPUR LIMITED (EPOL).

1. Pursuant to the decision of the Authority dated April 1, 2011 in the matter of Motion for Leave Review against the Authority's COD decision dated November 3, 2010 read with Corrigendum dated May 14, 2012, decision of the Authority dated September 17, 2013 in the matter of tariff adjustments on High Speed Diesel and mixed fuel and decision of the Authority dated June 9, 2016 regarding Engro Powergen Qadirpur Limited (EPQL), formerly Engro Energy Limited, the insurance component of tariff is subject to annual adjustment as per actual cost. EPQL requested to approve insurance component of Rs. 0.2246/kW/h and Rs. 0.2293/kW/h on Gas and HSD respectively, for the period of April 23, 2023 to April 22, 2024. EPQL in support of its request provided copies of insurance policies, premium calculations and payment acknowledgment receipts of insurers.
