S.R.O. 1558 (I)/2024.- In pursuance of Proviso-iv of Sub-Section 7 of Section 31 of the Regulation of Generation, Transmission and Distribution of Electric Power Act, 1997 (XL of 1997), NEPRA hereby notifies the Decision of the Authority dated September 20, 2024 along with revised fuel cost component attached as Annex-I, for the period July 01, 2024 to September 30, 2024 regarding the adjustment in fuel portion of energy charge part of tariff on account of variation in Gas prices in respect of UCH-II Power Private Limited in Case No. NEPRA/TRF-122/UCH-II-2008.

2. While effecting the Decision, the concerned entities including Central Power Purchasing Agency Guarantee Limited (CPPAGL) shall keep in view and strictly comply with the orders of the courts notwithstanding this Decision.

DECISION OF THE AUTHORITY IN THE MATTER OF FUEL PRICE ADJUSTMENT FOR THE PERIOD OF JULY 1, 2024 TO SEPTEMBER 30, 2024 FOR UCH-II POWER PRIVATE LIMITED.

- 1. Pursuant to the decision of the Authority dated July 3, 2017 in the matter of tariff adjustment at Commercial Operation Date (COD) and decision of the Authority dated April 24, 2018 in the matter of Motion for Leave for Review of Uch-II Power Private Limited (hereinafter "Uch-II"), the fuel portion of energy charge part of tariff of Uch-II is required to be adjusted for variation in the fuel price.
- 2. Oil & Gas Regulatory Authority (OGRA) vide its decision dated August 13, 2024 determined and notified the wellhead price of Uch-II natural gas delivered by Oil & Gas Development Company Limited (OGDCL) to Uch-II for the period from July 1, 2024 to December 31, 2024. Accordingly, Uch-II vide its letter dated September 11, 2024 requested for revision of fuel cost component on basis of latest notified revised gas price of US\$ 6.1184/MMBTU.
- 3. The Authority in its collective and joint wisdom considering all aspects decided with consensus as under; which will be hereafter called as decision of the Authority in the matter:-

"Based on OGRA's notified gas price and the request of Uch-II for adjustment in fuel cost component due to exchange rates variation, the revised energy charge part of tariff relating to fuel cost component of Uch-II has been revised. The revised fuel cost component is indicated hereunder and shall be immediately applicable on units delivered during the respective period."

- 4. The instant decision shall supersede the decision made on July 25, 2024 regarding Fuel Price Adjustment for July to September 2024.
- 5. The above decision of the Authority along with revised fuel cost component attached as **Annex-I** are to be notified in the Official Gazette, in accordance with the provisions of Section 31(7) of the Regulation of Generation, Transmission and Distribution of Electric Power Act 1997.
- 6. CPPA (G) to ensure that all payments are consistent with tariff determination(s).
