DECISION OF THE AUTHORITY IN THE MATTER OF FUEL PRICE ADJUSTMENT FOR OCTOBER TO DECEMBER 2024 QUARTER FOR UCH-II POWER PRIVATE LIMITED

- 1. Pursuant to the decision of the Authority dated 3rd July 2017 in the matter of tariff adjustment at Commercial Operation Date (COD), decision of the Authority dated 24th April 2018 in the matter of Motion for Leave for Review of Uch-II Power Private Limited (hereinafter "Uch-II"), the fuel portion of energy charge part of tariff of Uch-II is required to be adjusted for variation in the fuel
- 2. Oil & Gas Regulatory Authority (OGRA) vide its notification dated August 13, 2024 determined and notified wellhead price of Uch-II natural gas delivered by Oil & Gas Development Company Limited (OGDCL) to Uch-II for the period from 1st July 2024 to 31st December 2024. OGDCL also vide its letter No. PPK.2200 dated October 3, 2024 informed to the Uch-II that last notified gas price of US\$ 6.1184/MMBTU without GIDC of Rs. 100/MMBTU shall be applicable for October 2024 and onwards.
- 3. The Authority in its collective and joint wisdom considering all aspects decided with consensus as under; which shall be hereafter called as decision of the Authority in the matter:

"Based on OGRA's last notified gas price and Uch-II request with average exchange rate of the preceding quarter, the energy charge part of tariff relating to fuel cost component of Uch-II has been revised. The revised fuel cost component is indicated hereunder and shall be immediately applicable on unit delivered basis:

w.e.f. October 1, 2024 to December 31, 2024	4.0445	13.0780

- 4. The above decision of the Authority along with revised fuel cost component attached as Annex-I is to be notified in the Official Gazette, in accordance with the provisions of Section 31(7) of the Regulation of Generation, Transmission and Distribution of Electric Power Act 1997.
- 5. CPPA (G) to ensure that all payments are consistent with tariff determinations.
