ANNUAL ADJUSTMENT OF INSURANCE COMPONENT FOR JULY 1, 2022 TO JUNE 30, 2023 OF FFBL POWER COMPANY (PRIVATE) LIMITED.

Pursuant to the Authority's decision dated February 9, 2022 notified vide S.R.O. No. 1375(1)/2022 on 1. July 18, 2022 in the matter tariff adjustment at Commercial Operation Date of FFBL Power Company Limited (hereinafter refer as "FPCL"), the insurance component of tariff is subject to annual adjustment as per actual cost with maximum of 1% of EPC cost. FPCL vide its letter dated September 11, 2024 requested to revise the insurance component of Rs. 0.1692/kWh on the basis of insurance cost of Rs. 65,525,179/- for the period July 1, 2022 to June 30, 2023. FPCL in support provided copies of premium invoices and payment evidences. The detail of insurance premiums (net of sales tax/FED) is reproduced hereunder:
