- S.R.O. 49 (I)/2025.- In pursuance of Proviso-iv of Sub-Section 7 of Section 31 of the Regulation of Generation, Transmission and Distribution of Electric Power Act, 1997 (XL of 1997), NEPRA hereby notifies the Decision of the Authority dated January 08, 2025 in the matter of fuel price adjustments from Simple Cycle to Combined Cycle Operations on RLNG for October 2022 to April 2023 for Punjab Thermal Power (Private) Limited in Case No. NEPRA/TRF-408/PTPL-2017.
- 2. While effecting the Decision, the concerned entities including Central Power Purchasing Agency Guarantee Limited (CPPAGL) shall keep in view and strictly comply with the orders of the courts notwithstanding this Decision.

DECISION OF THE AUTHORITY IN THE MATTER OF FUEL PRICE ADJUSTMENTS FROM SIMPLE CYCLE TO COMBINED CYCLE OPERATIONS ON RLNG FOR OCTOBER 2022 TO APRIL 2023 FOR PUNJAB THERMAL POWER (PRIVATE) LIMITED.

- 1. Pursuant to the Authority's decision dated December 26, 2017 in the matter of tariff petition filed by Punjab Thermal Power (Private) Limited (hereinafter "PTPL") and decision dated June 7, 2018 notified vide S.R.O. No. 1059(10/2018 on August 27, 2018 in the matter of Motion for Leave for Review of PTPL, the fuel cost components of energy charge part of tariff of PTPL's are required to be adjusted on account of variation in fuel price(s).
- 2. PTPL previously through different requests applied for the revisions of its Fuel Cost Components (FCCs) on the simple cycle operations for the period from October 2022 to April 2023. The Authority through various decisions has approved fuel price adjustments w.e.f. October 24, 2022 to April 19, 2023 (before the synchronization of steam turbine with national grid) on simple cycle operations.
- 3. Accordingly, PTPL raised test energy invoices while applying simple cycle FCC on RLNG fuel till 19th April 2023 i.e. until before the synchronization of steam turbine with the national grid. However, CPPA-G viewed that for said period combined cycle mode's FCCs be applied instead of simple cycle mode's FCCs. Subsequently, CPPA-G advised PTPL to seek approval for the revision of FCCs on combined cycle mode from the Authority.
- 4. Therefore, PTPL vide its letter dated November 28, 2024 submitted request for price adjustments of fuel cost components on RLNG relating to electricity generated during the testing and commissioning period from October 2022 to April 2023.
- 5. The Authority in its collective and joint wisdom considering all aspects decided with consensus as under; which shall be hereafter called as decision of the Authority in the matter:-

"Based on information and documentary evidences submitted by PTPL and as per the Oil & Gas Regulatory Authority (OGRA) notifications of provisional weighted average RLNG prices for the relevant months, the fuel cost components of the energy charge part of tariff have been adjusted for the variation in RLNG price(s) for the respective periods for combined cycle operations. The revisions have been made on provisional basis and final fuel cost components shall be made after notifications of final RLNG prices by OGRA and submission of fuel invoices by PTPL."

6. The revised fuel cost components of energy charge part of tariff on combined cycle operation on RLNG indicated hereunder shall be immediately applicable on unit delivered during the respective periods:
