ADJUSTMENT MATTER OF **AUTHORITY** THE THE DECISION OF INSURANCE COMPONENT OF CAPACITY CHARGE PART OF TARIFF FOR THE PERIOD OF MAY 24, 2024 TO MAY 23, 2025 FOR ORIENT POWER COMPANY LIMITED (OPCL).

1. Pursuant to the decision of the Authority dated January 12, 2012 in the matter of Motion for Leave for review filed by Orient Power Company Limited (OPCL) against the decision of the Authority regarding adjustments in generation tariff at Commercial Operation Date (COD), the insurance component of tariff is subject to adjustment as per actual annually. OPCL requested to approve insurance component of Rs. 0.1490/kW/h for the period May 24, 2024 to May 23, 2025. OPCL in support of its request provided copies of insurance policies, details of no claim bonus and premium payment evidences. The details of requested insurance cost net of Federal Exercise Duty is as under:

- 3. The above decision of the Authority along with revised tariff schedule attached as Annex-I are to be notified in the Official Gazette, in accordance with the provisions of Section 31(7) of the Regulation of Generation, Transmission and Distribution of Electric Power Act 1997.
