DECISION OF THE AUTHORITY IN THE MATTER OF FUEL PRICE ADJUSTMENT FOR JANUARY TO MARCH 2025 QUARTER FOR UCH-II POWER PRIVATE LIMITED

- 1. Pursuant to the decision of the Authority dated 3rd July 2017 in the matter of tariff adjustment at Commercial Operation Date (COD), decision of the Authority dated 24th April 2018 in the matter of Motion for Leave for Review of Uch-II Power Private Limited (hereinafter "Uch-II"), the fuel portion of energy charge part of tariff of Uch-II is required to be adjusted for variation in the fuel price.
- 2. Oil & Gas Development Company Limited (OGDCL) vide its letter No. PPK.2200- on January 2, 2025 informed and certified to Uch-II that last Oil & Gas Regulatory Authority's (OGRA) notified gas price of US\$ 6.1184/MMBTU dated August 13, 2024 without GIDC of Rs. 100/MMBTU shall be applicable for January 2025 and onwards, which shall be subject to adjustment/revision as per notification of revised gas price(s) by OGRA.
- 3. The Authority in its collective and joint wisdom considering all aspects decided with consensus as under; which shall be hereafter called as decision of the Authority in the matter:

"Based on OGRA's last notified gas price and Uch-II request with average exchange rate of the preceding quarter, the energy charge part of tariff relating to fuel cost component of Uch-II has been revised. The revised fuel cost component is indicated hereunder and shall be immediately applicable on unit delivered basis:

w.e.f. January 1, 2025 to March 31, 2025	4.0445	13.0529
